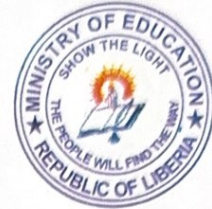

Bidding will be conducted through the National Competitive Bidding (NCB) procedures approved by the Public Procurement and Concessions Commission (PPCC) specified in the Public Procurement and Concessions Act (PPCA) and is opened to all bidders as defined in the Bidding Documents.

Qualification requirements include:

- Experience as prime contractor in the construction of at least three (3) works of similar value, nature and complexity in the last two (2) years
- Average annual turnover of construction works valued at least US\$100,000.00 during the last two (2) years.
- Evidence of access to financial resources of at least US\$30,000.00

- Ministry of Public Works and Association of Liberian Construction Contractors Certificate
- Bidder are required to submit 2% of their bid price quoted
- Evidence that you are registered with PPCC

Bids must be delivered in a sealed envelope to the address below on or before **Friday, January 12, 2024 at 2:00 p.m.** Bids will be opened in the presence of the bidders' representatives who choose to attend on **Friday January 12, 2024 at 2: 00 p.m. in the Conference Room** of the Ministry of Education. **Please note that Electronic bids are not accepted. Late bids will be rejected.**

All bids shall be accompanied by a **Bid-Security** as described in the bidding document. **Please note that bidders must declare for a period of 180 days.**


