The Government of Liberia has received a grant equivalent to USD 47 million from the International Development Association (IDA) to implement the Improving Results in Secondary Education (IRISE) Project, hereinafter “the Project”. The Project duration is four years. The Ministry of Education (MoE) is the IRISE implementation agency responsible for project execution and results monitoring. 3. **There will be no margin of preference.**

4. Bidding will be conducted through Open National Competitive Procurement using Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers-Procurement in Investment Projects Financing" **July 2016 and revised November 2017 and**

August 2018 and Fourth Edition, November 2020 (“Procurement Regulations”), and is open to all eligible Bidders as defined in the Procurement Regulations that must have the following:

(A): A Bidder registered within Liberia:

(i) Valid Legal Status of Company:

Certificate of Incorporation

Certificate to Commence business

(ii) Properly executed Power of Attorney

(iii) Valid Income Tax Clearance Certificate for the last 3 years.

(iv) Valid Liberia Ministry of Public Works/CCCS Building Certification type: BO-12, B10-12, B11-12.

(v) Valid Social Security Clearance Certificate

(B): The Bidder registered outside Liberia:

(i) Valid Legal Status of Company

Certificate of incorporation and necessary legal permits to conduct business

(ii) Valid Labour certificate from home country indicating that the company has been working and compliant with labour regulations in the home country.

(iii) Valid Income Tax Clearance certificate from home country indicating that company has duly paid all his/her tax liability over the last three years

(iv) International Contractors must possess an equivalent Valid MWH certificate of classification of at least B10 (**Public buildings for school and college**) in Liberia from their home country. This also is a proof that the company is a recognised construction firm from the appropriate regulatory body of their home country. 5. A Bidder may bid for any or all Lots and evaluation of Bids will be on a Lot-by-Lot basis. However, in the event that a Bidder wins more than one Lot, such Bidder must demonstrate that it meets the qualification criteria for such Lots and can mobilize to all site concurrently. In addition, such Bidder cannot propose to use the same personnel and equipment for more than one Lot.
