The *Ministry of Education* [has received a grant and financing from the World Bank towards the cost of the *project grant*, and intends to apply part of the proceeds towards payments under the contract ¹for [Printing of Students' Workbook and Teachers Guild for the Accelerated Learning Program-ALP, Ministry of Education]². For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank's Disbursement Guidelines for Investment Project Financing.”
2. The *Ministry of Education* now invites sealed Bids from eligible Bidders for **Printing of Students' Workbook and Teachers Guild for the Accelerated Learning Program-ALP, Ministry of Education of Non-Consulting Services required, including quantities, location, delivery period, etc.**³.
3. Bidding will be conducted through National competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers -" and the [Bank Policy on Corrupt and Fraudulent Practices](#) ("Procurement Regulations"), and is open to all eligible Bidders (or only to prequalified Bidders as the case may be) as defined in the Procurement Regulations.
4. Interested eligible Bidders may obtain further information from *the Ministry of Education Congo Town, Ministerial Complex, Procurement Section, Room#419, 3rd floor, beginning Wednesday December 8, 2021* and inspect the bidding documents during office hours from 9:00a.m to 4:00p.m daily at the address given above.

The method of payment will be cash and a receipt will be issued to the bidder upon payment.⁵

Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below [*Ministry of Education, mini conference Room, 4th Floor, Ministerial Complex, Congo Town @ 10:10a.m.*
7. All Bids must be accompanied by a "*Bid-Securing Declaration,*" as appropriate.
8. "Attention is drawn to the Procurement Regulations requiring the Borrower to disclose information on the successful bidder's beneficial ownership, as part of the Contract Award Notice, using the Beneficial Ownership Disclosure Form as included in the bidding document."
